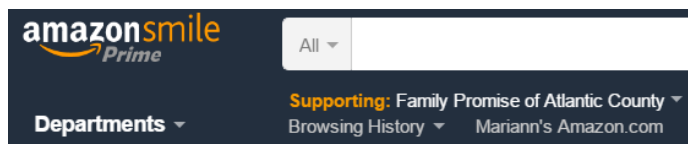

NOTICE IS HEREBY GIVEN that the **ANNUAL MEETING of the UUCSJS will be held in the Sanctuary of the UU Center on SUNDAY, JUNE 4, 2017 at 11:15 am** (immediately following the Sunday service) for the purposes of approving the budget for the 2017-18 Fiscal Year; electing members of the Board of Trustees and Nominations Committee; electing delegates to the UUA General Assembly; receiving the final report of the Ministerial Search Committee; revisiting our involvement in issues of racial and social justice as mandated at the "Congregational Conversation" Session on October 2, 2016; and transacting such other business as may come before the congregation.

*~ Notice will be distributed to members' email addresses of record as available, and others by regular mail, no less than thirty (30) days in advance of the meeting, as the UUCSJS Bylaws require; in other words, on or before **May 6, 2017**.*

Three Ways to Vote:

1. **By attending the meeting in person** (you must be a member in order to vote). (*A quorum must be present in order to conduct the business of the congregation.*)
2. **By Absentee Ballot** – An Absentee Ballot will be available and must be received by the Board secretary before the start of the Annual Meeting at 11:15 a.m., June 4, 2017 in order to be counted.
3. **By Proxy** – A Proxy Letter signed by the absent member authorizes another member to vote on the absent member's behalf. Members may easily create their own proxy letter. The proxy letter names the proxy and states that said proxy is authorized to vote on behalf of the named member at the meeting named and is properly signed and dated. The proxy letter shall be presented to the Board secretary or to the meeting moderator on or before the opening of the Annual Meeting. No member may vote more than two (2) proxies per meeting. A proxy is valid for one (1) meeting only, and can be used on all matters other than the amending of bylaws.

Board of Trustees HIGHLIGHTS April 2017

The **regular monthly meeting** of the **UUCSJS Board of Trustees** was held on **Tuesday, April 11, 2017** at 6:30 pm in the Sanctuary at the UU Center, President Jim Gentile presiding. All Board members were present, as was ex-officio member, Rev. John Marsh, Interim Minister.

►Agenda Items

• **Treasurer's Report.** Treasurer Karen York distributed her written report for April showing **account balances** (3/31) as follows: TD Checking (Operating funds): \$24,951.07; TD Savings (CC3/Capital funds): \$250.01; and Fidelity/Capital Reserves: \$10,640.88 (\$10,747.59 Operating). **Current principal balance on mortgage** = \$225,946.81 (3/31).

– **Stewardship Campaign.** The treasurer's report detailed the following: **a)** Four gatherings were held; **b)** \$147,975 has been pledged to date from 58 out of 83 pledging families; **c)** many increased their pledges this year (\$12,000 over last year); **d)** final projected pledge income = \$156,000 (compared to \$145,090 last year); and **e)** the Fellowship Dinner on Saturday, April 22 will celebrate the end of a successful campaign.

– **Ongoing projects.** This month's projects have included development of 2017-18 draft budget, and continuing Ministerial Search support to put together the salary and benefits package.

– **Computer upgrade request.** —A motion to approve expenses to upgrade hardware and software, and to cover consulting fees as needed, as requested in the proposal from Kathleen Hartnett, Congregational Bookkeeper, dated April 9, 2017, was adopted unanimously. The expenses were estimated as follows: Desktop computer tower running Windows 10 (\$300); QuickBooks upgrade (\$200-300); Microsoft Office upgrade (\$229); and consulting fees (to be determined).

– **Building use requests.** The treasurer listed current uses, including: 1) Organizational meeting for League of Women Voters (LWV) [UUCSJS contact Jesse Connor], Thursday, April 27 at 7 pm (*fee waived*). [Requested by Jesse and Barbara Fiedler; LWV is non-profit/non-partisan, no chapter in Atlantic County; group may later meet in local libraries but use of UU to organize is appreciated.] 2) Citizens' Climate Lobby of Atlantic County (CCL-AC) [Anne Maiese, Group Leader; UUCSJS contact Colby Tippins], second Saturday of each month (*fee waived*).

• **Minister's Report.** Rev. Marsh reported that two weeks ago he had attended "Better Together: Central East Region (CER) Leadership Day and UUA Presidential Candidates Forum." The event was held at Cedar Lane UU Church in Bethesda, MD, on Saturday, April 1. All three presidential candidates—Reverends Susan Frederick-Gray, Allison Miller, and Jeanne Pupke—are good choices, Rev. Marsh said; he endorses Allison Miller. [*Note: The Presidential Candidates Forum can be viewed online.*]

Then this past week, for three days he attended the UU United Nations Office's "2017 Intergenerational Spring Seminar," *Arm in Arm: Interfaith Action to Disarm Our Planet*, on April 6-8 in New York City. Up until now UU-UNO events have usually been held in a church building across from the U.N., he said, but this time moved to a white neighborhood up near Harlem and had a hostel where the youth were sleeping.

Rev. Marsh next described to the Board in some detail recent events surrounding the resignation of UUA President Peter Morales, and others, with just three months left in his term of office. (A three-person presidency has now been announced to govern until the election of the new UUA president at General Assembly from June 21-15, 2017 in New Orleans.) All three candidates referred to the national crisis in leadership at the CER forum in Bethesda, he said, and added that personally, "I'm not worried about the association!"

Finally, Rev. Marsh brought up the call by Black Lives UU (BLUU) for congregations to participate by holding a "white supremacy teach-in" on one of two Sundays, April 30 or May 7. **OUTCOME:** After discussion, the Board determined that our priority must be working to insure a successful "Candidating Week" (May 14 to May 21, with an orientation on May 7). Several commented that our actions in support of Black Lives Matter have been and will continue to be extremely important at UUCSJS and are ongoing in our community.

• **Candidating Week: Overviews & Expectations.**



It was noted for the record that the *Ministerial Search Committee* (MSC), at the Sunday, April 9 service, *happily announced that our search had been successful and introduced Rev. Dawn C. Fortune* (left) by way of a short video addressing the congregation directly. Board members then spent time on how "Candidating Week" (Sunday May 14 through Sunday May 21, culminating in a Special Congregational Meeting on May 21 for the purpose of formally "Calling" the new Minister) unfolds. Many types of gatherings will be held so that congregants and Rev. Fortune can get to know each other. The Settlement Handbook recommends that a special task force be created to assist the MSC with arrangements; Jim Gentile, Melissa Hutchison, and Damon Smith kindly offered to serve. Before the discussion closed, Rev. Marsh shared a few observations and noted that, in a sense, in calling a minister, "the congregation is voting on the work of the MSC."

• **Congregational Strategic Planning.**

New Strategic Planning team. At present, the subcommittee to develop our new three-year strategic plan will consist of the following five (5) members: Marsha Hannah, Charlie Roberts, Jessica Dunn Safonof, Geoff Stuart, and Art Wexler. A sixth member, Rosemary Noonan, may also join the team.

• **Release of funds for Soup Kitchen freezer.**

A motion to approve releasing funds from the special collection at the service on Christmas Eve (12/24/16), to be donated to Asbury United Methodist Church in Atlantic City towards purchase of a freezer for use by their soup kitchen (approx. cost = \$598), was adopted unanimously.

• **Children's Religious Education (CRE) Report.**

Sunday Child Caregiver. Along with her monthly report, Heidi Janssch, Director of Religious Education (DRE), sent the document, "UUCSJS Sunday Caregiver Job Description – *First Draft*," for Board comment and approval. (This document will then be added to the Personnel Manual.) **OUTCOME:** The secretary offered minor copyediting and will contact the DRE prior to Board approval, and the matter was tabled.

• **Family Promise of Atlantic County (FPAC).**

The Board noted that our UUFPP team, led by co-chairs Deb Dagavarian and Barb Morell, has concerns about some aspects of FPAC's start-up. They are monitoring the situation to confirm that there will be families enrolled before signing up volunteers for our next hosting week (Sunday, 4/30 to Sunday, 5/7). Also, the president has ascertained that one congregant who might have been willing to seek service on the FPAC Board has declined and another candidate may be sought.

After extinguishing the chalice, the meeting adjourned at 8 pm.

A Reflection on the Search

Paul Utts, Member of the Ministerial Search Committee

After two years on the ministerial search committee and reviewing several candidates, I found that Rev. Dawn Fortune's ministerial record outlined a unique journey and call to ministry. The next step in the process was to read their sermons; and this further highlighted a diverse life, not the usual middle-class, highly-educated perspective demonstrated by so many in our faith. Their ability to transcribe this unique journey into universal life lessons and articulate these lessons into digestible sermons piqued my interest, as well as the rest of our search committee.

Now in the process of reviewing Rev. Fortune's work, the issue of preferred pronouns – they & their, instead of she & her – came out. My first response, even though I had spent two lessons in teaching *Our Whole Lives* was, "Hey, those words are already in use, don't make me learn new usage." I spent considerable time (a week) rationalizing in my head and sometimes out loud about why I was uncomfortable with this. I worked through this with the rest of the committee and gained in the process another example of how my white, middle-class, cis-heterosexual life had left me blind to the subtle hurts that even us "enlightened" UUs often fail to see. I hadn't even met Dawn yet and already my mind and my perception of the world was growing.

The next step in the process was checking Rev. Fortune's references. I had the pleasure of talking with two people in Mission Peak, California. This Congregation was recently awarded the UUA's Break Through Congregation 2016. I spoke with two people: their Minister, Rev. Nickel, and another woman who is the head of her company's human resource department. Both gave glowing references of Dawn's time with them as an intern and how many of their congregants were hoping Dawn would end up somewhere nearby so they could continue to hear Dawn's sermons.

Our committee then had the privilege of spending a weekend with Rev. Fortune culminating in a sermon. Not one of us left unimpressed; their ability to focus and truly listen, including the issue of pronoun use, was as ministerial as I have experienced. The sermon they delivered had people agreeing out loud, and the affirming looks on the faces of the congregation as they filed out of the sanctuary was enough to convince me that we had "hit paydirt." Now, Reverend Fortune had been offered opportunities closer to where they grew up, so there was no guarantee that they would choose us. Other candidates had said no.

When we heard back after Dawn had met with other congregations, that they thought UUC of the South Jersey Shore seemed to be a good fit, we were all elated. Finally, after two years in search, a candidate we were excited about was also excited about us. A candidate that even though they were looking for full-time ministry, saw the potential in us and the confidence in themselves that together, we could make full-time ministry happen.

I feel certain that after reviewing Rev. Fortune's work, and after meeting them and hearing a couple of sermons, that there will be a new voice in South Jersey, and together, with Rev. Fortune's help, our voice will be heard in a time when so many are in need of what we have to say.

The UUCSJS By-Laws governing the action of Calling a Minister read as follows:

Article IX. THE MINISTER

Section 9.5 The Called Minister

- a) **Appointment and Dismissal of the Called Minister.** The appointment of the Called Minister shall be by written ballot and shall require a two-thirds vote of those Members of the Congregation present and voting (including Absentee Ballots) at a Congregational Meeting called specifically for that purpose. The appointment of the Called Minister shall be for an indefinite period. Dismissal of the Called Minister shall be by written ballot and shall require a two-thirds vote of those Members of the Congregation present and voting (including Absentee Ballots) at a Congregational Meeting called specifically for that purpose.
- b) **Letter of Covenant and Agreement of the Called Minister.** The Called Minister shall have a written Letter of Covenant and Agreement with Members of the Congregation. The Board of Trustees shall act as agent for the Congregation in its negotiation, implementation, and review.

VOLUNTEERS NEEDED for our ANNUAL NATIVE PLANT SALE

Friday, May 5 and/or Saturday, May 6

Spring 2017 marks the 7th anniversary of our Annual Native Plant Sale and we need volunteers to help on **Friday, May 5 and/or Saturday, May 6**.

Please consider signing up to help out – it's fun! This sale is a win-win. We raise funds for UUCSJS (last year we raised \$4,000+!) while also spreading the message of the importance of sustainable landscaping to folks in southern NJ. *NOTE: Our plant sale has grown so large that the native plant swap, which previously was held on the Saturday of the sale weekend, has been moved to June 19 and will precede a meeting of the Southeastern Chapter of the Native Plant Society of New Jersey which will take place at UUCSJS.*

Here are some of the tasks we need to accomplish to make this year's sale a success:

1. Off-load and set up seventy-three (!!) species of perennials, shrubs, and trees
2. Organize plants into participant's orders, double-check orders.
3. Set up tables, chairs, signage, and shade.
4. Help participants check over orders, load plants into vehicles.
5. Administer refunds.
6. Provide volunteer support by contributing food and/or beverage for Friday morning volunteers.
7. And here's our most talked-about volunteer need: protector(s) of-the-plants. Open to Men's Group volunteers who are willing to brave the elements, drink beer, and talk far into the night all the while keeping our plants safe from marauding deer!

Since October 2016, the UUCSJS Men's Group has been assisting in staffing Asbury Methodist Church's Soup Kitchen on the third Saturday of the Month in Atlantic City.

On Christmas Eve, the collection taken at the service was dedicated to purchasing a storage freezer for the soup kitchen. We were told by the staff that a freezer would assist them in purchasing and storing in bulk. Between the money collected on Christmas Eve and a donation from the Men's Group, our Congregation was able to fully pay for the freezer. The Asbury Methodist staff finished its search in April, and the new freezer was delivered and made operational for the third Sunday in April.

On behalf of the Men's Group and also Asbury Methodist Church, thank you to everyone for their generosity in making this important donation to most important work.
